Background

The forthcoming “Seminar on Recent developments on Economic and Commercial Legislation in Latin America” in Rome (“Sapienza” University) will be hosted in Italy, and organised by “Sapienza” University of Rome, Master in International Business Law (IBL) and the Chair of International Business Law (prof.
